1. Introduction:

The promotion of research is a one of the significant responsibility of our college. - o Timely information on call for proposals on minor and major projects are provided



- o Timely auditing of funds is done and utilization certificate is sent to funding agencies
- o In Teachers Academy talks are delivered by the teachers based on their research and experiences
- o All teachers guide LL.M II year students in completing their dissertations

8. Initiatives for Research Awareness

The faculty engaged in research work publish research papers, participate in International, National, State and University level Conferences, Seminar and Workshops. They share their experiences with students.

- The departments of Law, Political Science Physical Education and Library Sciences have been active in research work; their papers have been published in International journals with impact factors.

- Transfer of research findings in the form of publications is open to the society and the upcoming academicians for reference

- Various research articles were presented in front of the Resource person and a book of Proceedings was also published. This created a very good academic and research environment on the college.

9. Budget Allocation for Research

There is provision in the budget for research activities Minor Research, Participation in Seminar, workshop and Conferences, as the government does not have any such allocation. However, the faculty is encouraged to apply for research proposals to different funding agencies such as SRTMU, Nanded, UGC, etc. to obtain grants. All infrastructural supports are provided by the institute.

10. Financial Support to Student Research Project

Though the college does not directly support financially to students for their research work but institutions provide all required infrastructure like books, computer, internet, equipment, etc. to UG, PG and research students. These facilities are indeed supported by the fee that is collected.

Support is also given to the students when they organize a Students Seminar with the publication of research articles in the form of book of proceedings. Resource persons are invited to chair the paper reading sessions of the students.

Ongoing Minor research project is interdisciplinary in nature. Infrastructural research facilities are shared. LL.M II year students are insisted to opt interdisciplinary research topics for dissertations
