







3. Constitution Day celebrations National Webinar on 'Constitutional Morality: An emerging doctrine to protect basic human values' 26.11.2021.

8.Essay writing competition held on 19-07-2022


Legal Aid Clinic had organized the essay writing competition on the pivotal topics of recent developments to sensitize them on the issues and develop their writing and explaining skills




10) National Webinar on 'Criminal Law and Protection of Women in India'25th Feb 2022
