This is the motto of the Guidance and Counseling Cell which functions as a part of students support service for student orientation. The cell nurtures student through different activities and allows student to cross hurdles in the academic year thereby marching smoothly towards success.

#### **Soft skill training Career counseling programs:**

The Career Guidance and Placement Cell helped students to prepare for suitable career options and created a lot of job opportunities for the students. The cell has conducted coaching, workshops and training programs on career orientation, higher study options, self-employment, and entrepreneurship management to make the students aware of educational and career choices. Experienced resource persons gave career counseling to students.

To facilitate the students in recognizing and nurturing their talents, various soft skill training programs were arranged on communication skills, personality development, stress management and preparation of Judicial Examination, Career Counseling, Curriculum Vitae, and Interview sessions were organized for students. 
The distinguished guest for the occasion was Mr. Sachin B. Chavan, an eminent lawyer from the District & Sessions Court Latur.
