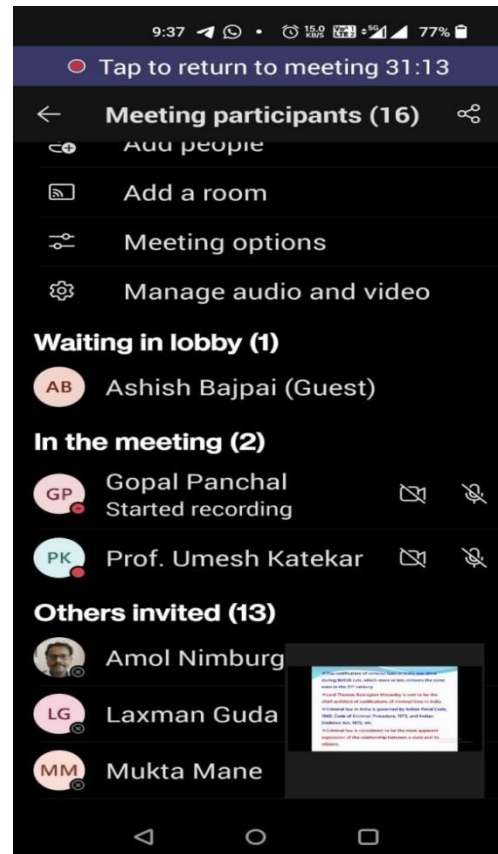

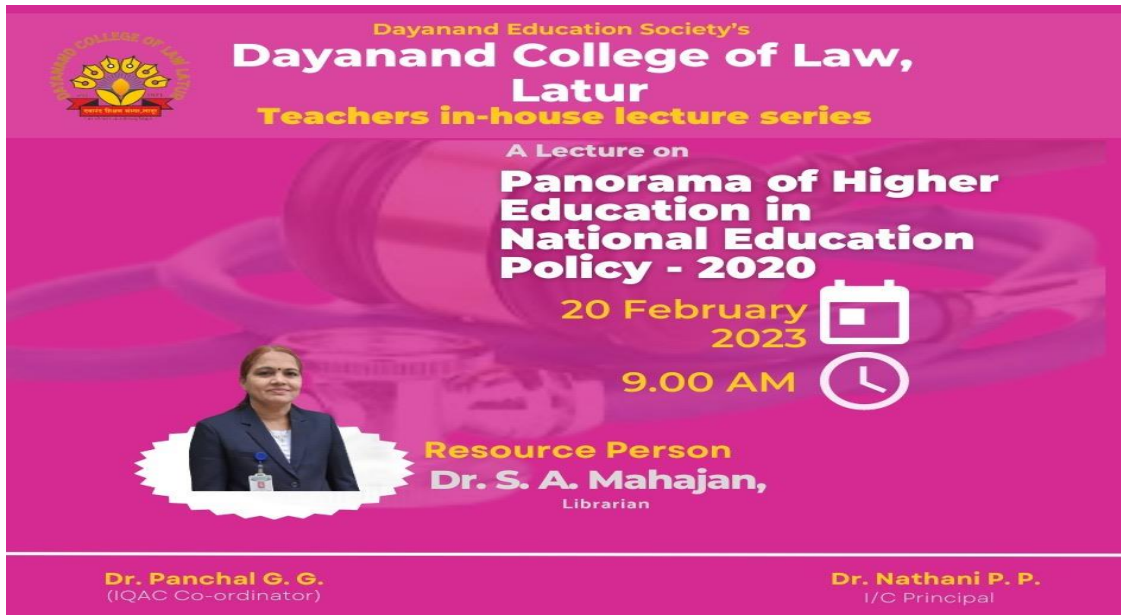

3. Lecture on Panorama of Higher Education in National Education Policy - 2020

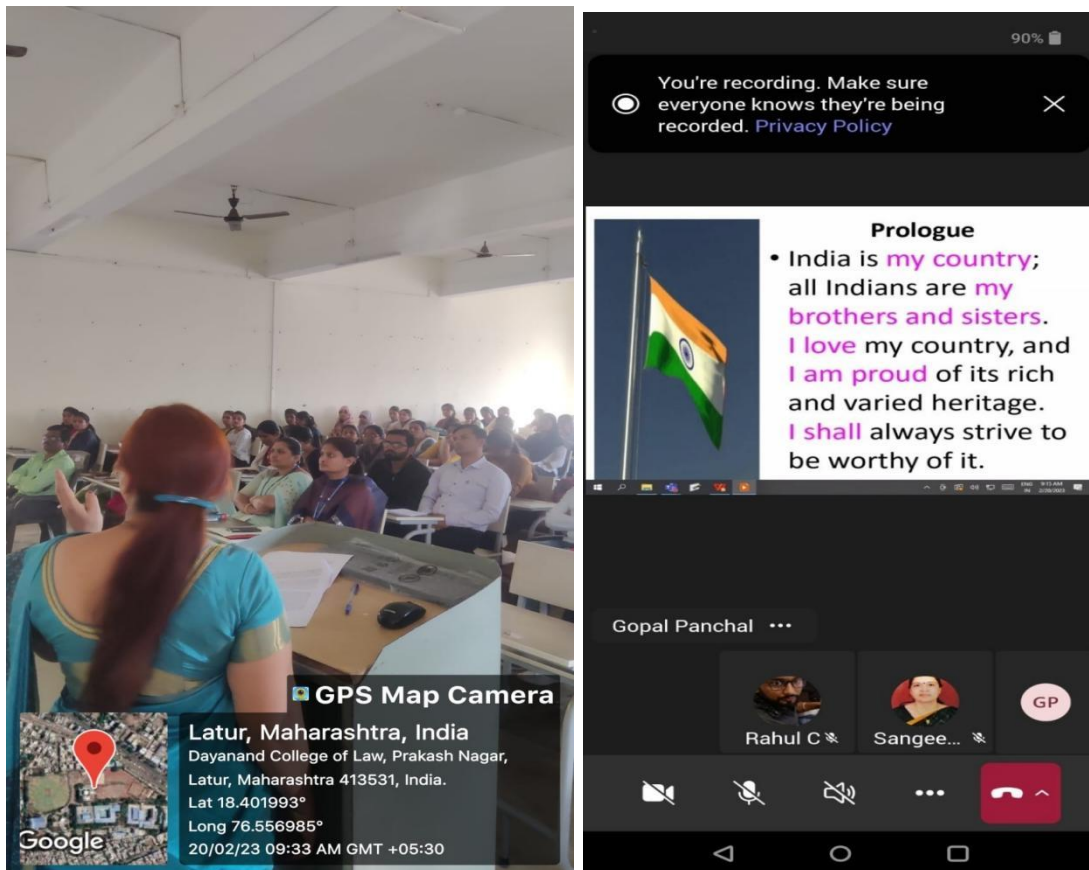

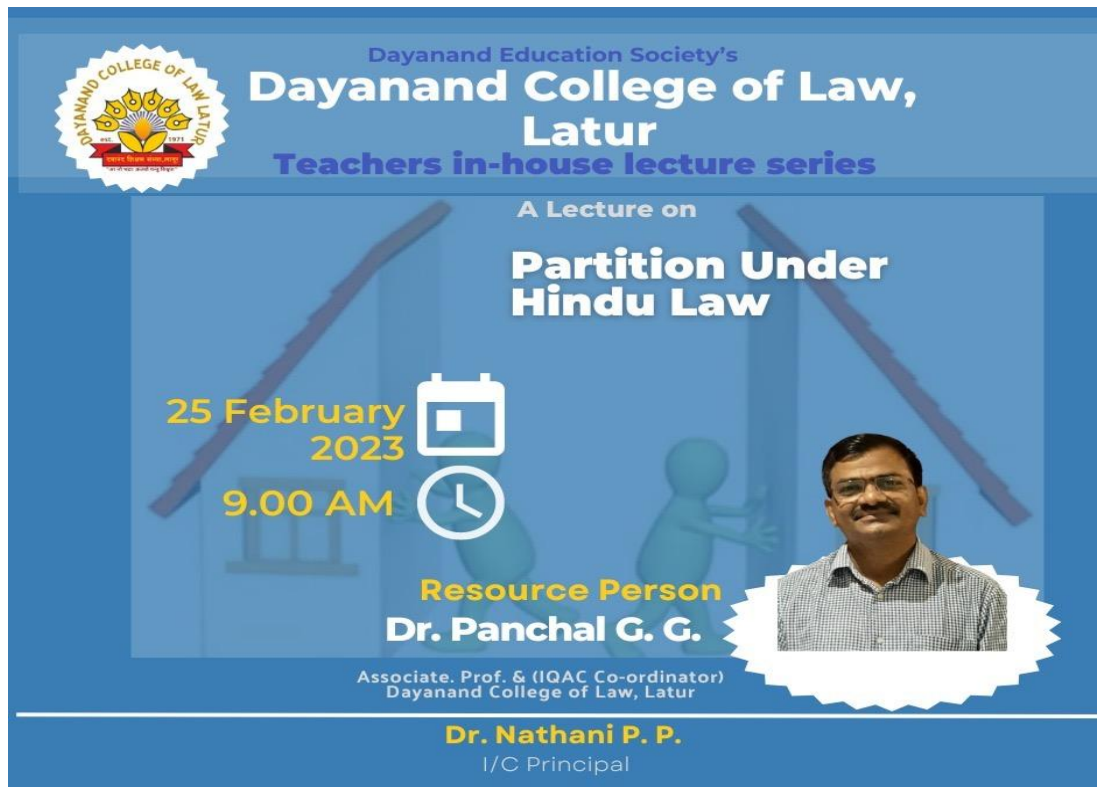

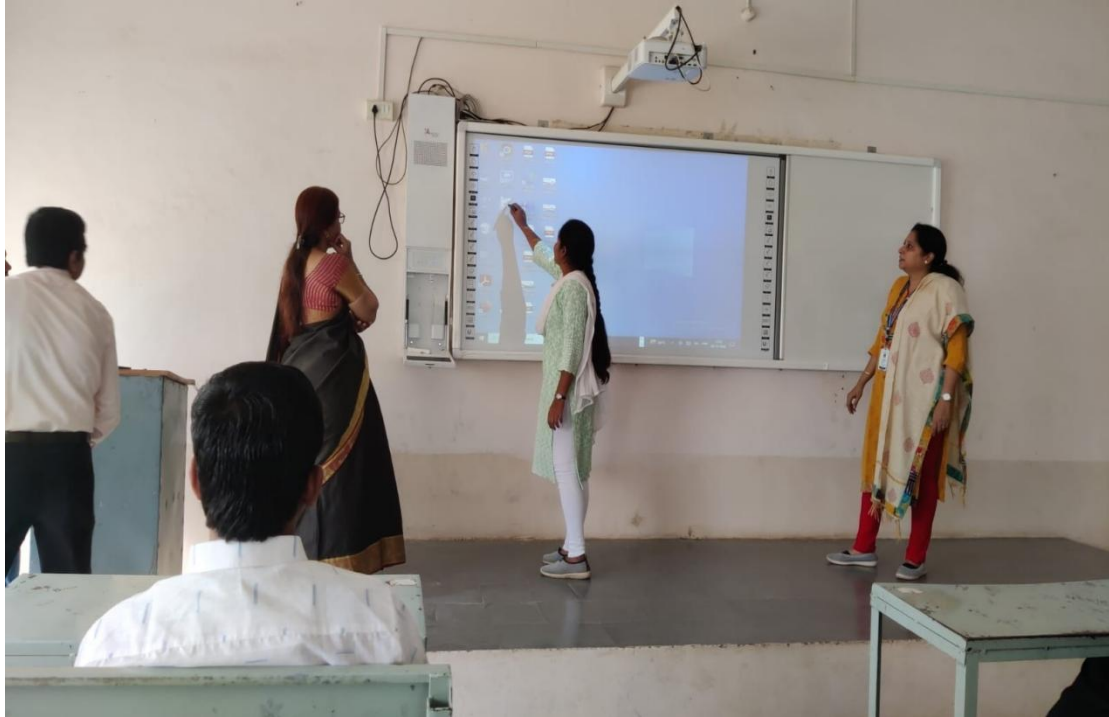
