Dayanand College of Law resolves to establish a centre for advancement of human rights and thus established "Human Rights Education Centre" in 2011. Ever since its establishment the centre has been doing a meritorious service in the advancement of human rights, which would go a long way in creating a society full of tolerance, mutual respect, dignity and above all sensitivity towards all by all.

The activities of the Centre are two folded:

 Co-curriculum Aspect: An academic programme as a part of co-curriculum by running a Certificate Course in Human Rights Education, and; 2. Practical Aspect: In the practical aspect, conducting human rights awareness programme like, seminars, workshops, public rally's, human rights awareness programme's at villages, legal aid programme's and so on.

The Human Rights Education Centre of the College works hand in hand with various govt. and non-governmental agencies. The Centre takes the active support from Women Studies Centre and National Service Scheme and Legal-Aid Clinic of the College in furtherance of Human Rights Education. The Centre work with an object of involving all the students to become sensitive to human related issues and to become more responsible citizens and committed professional in advancement of human rights. Under the auspicious of Human Right's Centre, various programmes are conducted and few of them are listed below.

1. Certificate Course in Human Rights Education:

This is a six months programme offered as an add-on programme for +2 qualifications. The certificate will be issued by The Swami Ramanand Teerth Marathwada University, Nanded which helps the students to find placement with NGOs. The students are encouraged to participate in human rights protection activities. Every academic year two batches of students will have offered this programme.

2. Practical Aspect:

1. <u>Certificate Course in Human Rights Education</u>:

Human Right Education Center has conducted Certificate Course in Human Rights total 32 students from various backgrounds were admitted to the Course. The Course is comprised with two papers which focus on basic issues of Human Rights and deal with the elements of good governance, duties of various State and Non-State agencies in respect of Human Rights implementation.
