Introduction.

Dayanand College of Law resolves to establish a centre for advancement of human rights and thus established “Human Rights Education Centre” in 2011. Ever since its establishment the centre has been doing a meritorious service in the advancement of human rights, which would go a long way in creating a society full of tolerance, mutual respect, dignity and above all sensitivity towards all by all.

The activities of the Centre are two folded:

1. Co-curriculum Aspect: An academic programme as a part of co-curriculum by running a Certificate Course in Human Rights Education, and;

2. Practical Aspect: In the practical aspect, conducting human rights awareness programme like, seminars, workshops, public rally's, human rights awareness programme's at villages, legal aid programme's and so on.

The Human Rights Education Centre of the College works hand in hand with various govt. and non-governmental agencies. The Centre takes the active support from Women Studies Centre and National Service Scheme and Legal-Aid Clinic of the College in furtherance of Human Rights Education. The Centre work with an object of involving all the students to become sensitive to human related issues and to become more responsible citizens and committed professional in advancement of human rights. Under the auspicious of Human Right's Centre, various programmes are conducted and few of them are listed below.

1. Certificate Course in Human Rights Education:

This is a six months programme offered as an add-on programme for +2 qualifications. The certificate will be issued by the Swami Ramanand Teerth Marathwada University, Nanded which helps the students to find placement with NGOs. The students are encouraged to participate in human rights protection activities. Every academic year two batches of students will have offered this programme.

2. Practical Aspect:

Following listed programs are conducted by the Center:

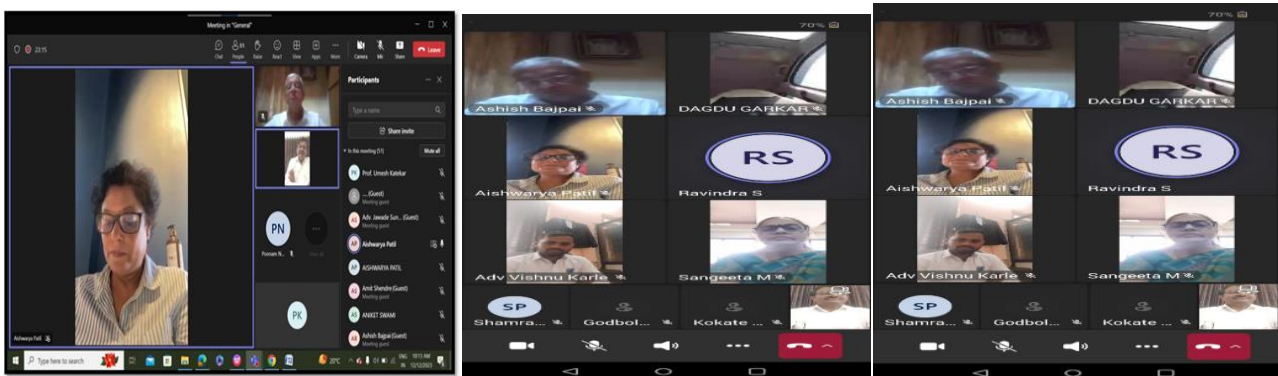
❖ **International Webinar on the topic "Human Rights and Human Rights Organisation".**

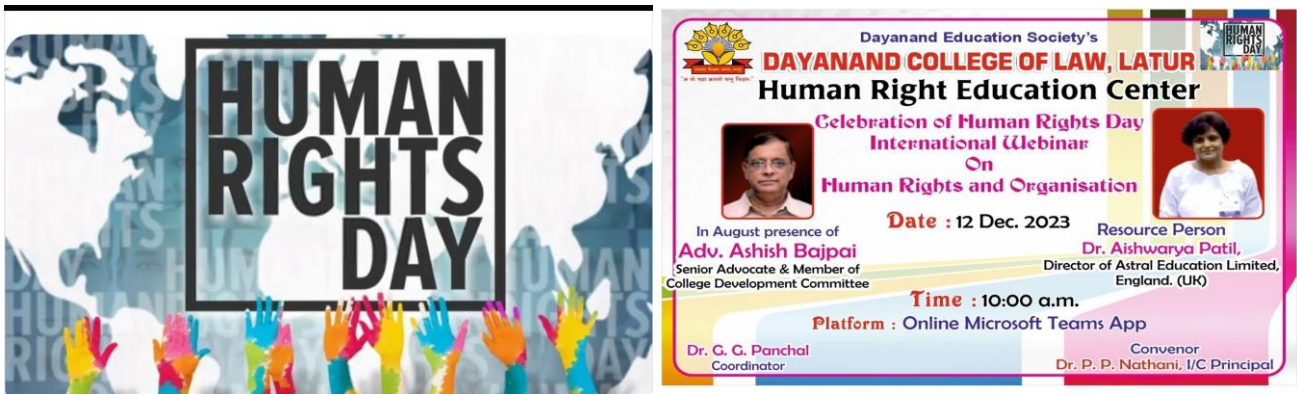

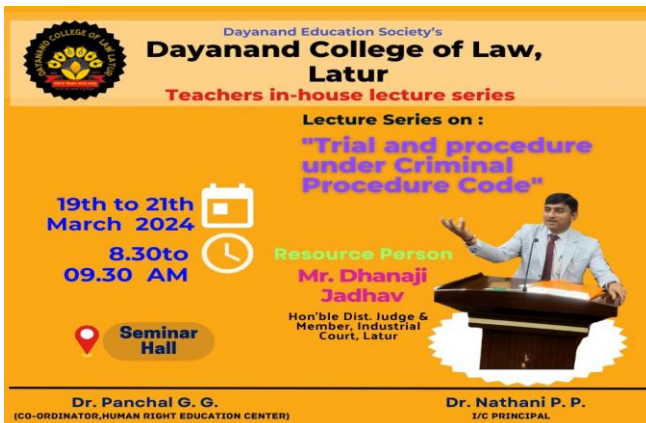

❖ **Lecture Series on Probation of Offender and Juvenile Justice Act during 4th to 5th April, 2024.**

A two days Lecture Series was conducted in Seminal Hall of the College during 4th to 5th April, 2024 on the topic Probation of Offender and Juvenile Justice Act. Mr. P. T. Gotey, Hon'ble Civil Judge Senior Division, Latur was invited as Resource Person of the Lecture Series. Lecture Series was commenced with felicitation of Mr. P. T. Gotey in the hands of Dr. Poonal Nathani, I/C Principal of the College. Lecture series was arranged for final year students to understand the practical reality of the legal framework of both of the Acts. The resource person has highlighted many aspects of the Acts including rehabilitation process of young offenders. The lecture series was conducted with the help of power point presentations. The stages to release of Juvenile on Probation, admonition, conditions of release, breach of conditions and its consequences, role of Probation Officers and his report on Juvenile. With regard to Juvenile Justice Act resource person has highlighted various terms and expressions used, amendments and supporting case laws and role of NGO's, rehabilitation institutions, composition of Juvenile Justice Board, Committees and their role in rehabilitation process of young convicts.
