In addition that, it is also discussed and decided in the meeting that, to display the anti-ragging committee, squad committee in the conspicuous place of the institution.

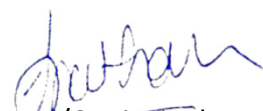
5. Students Complaints- if any—
