ANTI-RAGGING NOTICE AND MINUTES OF THE

MEETING ACADEMIC YEAR 2025–26

All the members of the teaching faculty and other staff are hereby informed that an Anti-Ragging Meeting is arranged on **18 August 2025 at 1:00 PM** in the **Principal's Office**. All are requested to attend the meeting without fail.

Agenda of the Meeting:

- Formation and reconstitution of the Anti-Ragging Committee and Anti-Ragging Squad for the Academic Year 2025–26.
- To develop an effective mechanism for creating awareness among students regarding ragging, its causes, consequences, and preventive measures.
- To organize screening of UGC-prescribed anti-ragging awareness videos for students.
- To ensure submission of Anti-Ragging affidavits by students and parents at the time of admission.
- Review of students' complaints, if any, and discussion on preventive action.

Dr. Jadhav N. D., Coordinator of the Anti-Ragging Committee, cordially welcomed all the members present for the meeting.

Thereafter, the agenda was placed before the committee for discussion and resolution.

1. Formation of Anti-Ragging Committee and Anti-Ragging Squad

The Anti-Ragging Committee and Anti-Ragging Squad were constituted for the Academic Year 2025–26 as per the guidelines of the UGC.

The Committee consists of the following members:

1. Principal of the College – Chairman
2. One faculty member – Coordinator
3. Other faculty members, including lady teachers
4. External members from Police Department, NGOs, Media, etc.
5. One member from Non-teaching Staff
6. Two student members, including one female student

The Anti-Ragging Squad is also formed from among the teaching faculty.

2. Mechanism for Awareness Program

The committee discussed the need to establish a structured mechanism to create awareness among students regarding ragging, its causes, consequences, and prevention. It was resolved that awareness programs, orientation sessions, and regular interactions with students will be conducted. Further, committee members will undertake periodic rounds in areas such as the canteen, playground, and other common places to ensure a ragging-free environment.

3. Awareness Videos on Anti-Ragging

It was discussed and resolved that awareness videos on anti-ragging, as prescribed by the UGC, will be shown to students at regular intervals to sensitize them about the seriousness and legal consequences of ragging.

4. Anti-Ragging Affidavit and Preventive Measures

To prevent ragging incidents, it was decided to obtain Anti-Ragging affidavits from both students and their parents at the time of admission. The institution has also incorporated Anti-Ragging rules and regulations in the college prospectus.

Further, it was discussed and decided to display details of the Anti-Ragging Committee and Squad prominently at conspicuous places within the institution to ensure visibility and accessibility.

5. Students' Complaints

No complaints regarding ragging or any mischievous behavior were reported by the students.

The meeting concluded with a vote of thanks proposed by the Coordinator of the Anti-Ragging Committee.
